A JOINT RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE PORT OF CHELAN COUNTY, THE BOARD OF COMMISSIONERS OF THE PORT OF DOUGLAS COUNTY, THE GOVERNING BOARD FOR PANGBORN MEMORIAL AIRPORT, AND THE BOARD OF DIRECTORS OF THE CHELAN DOUGLAS REGIONAL PORT AUTHORITY REGARDING JOINT DEFENSE, INSURANCE AND LITIGATION

WHEREAS effective June 25, 2019, the Port of Chelan County ("POCC") and the Port of Douglas County ("PODC") formed the Chelan Douglas Regional Port Authority ("CDRPA") to functionally consolidate the operations and activities of the POCC, the PODC, and Pangborn Memorial Airport ("PMA") consistent with the Interlocal Cooperation Agreement dated June 11, 2019 ("ILA").

WHEREAS the ILA anticipates a Plan of Consolidation and the adoption of Resolutions to address various matters that need to be resolved prior to January 1, 2020 (the "Functional Consolidation Date").

WHEREAS as part of the Plan of Consolidation the POCC and PODC agreed to address risk management and legal support.

WHEREAS the POCC, the PODC and PMA obtain insurance through Enduris and PMA also obtains an Airport Owners and Operators General Liability Policy through Chubb Insurance and a Storage Tank Pollution Liability Policy through Colony Insurance Company. The declaration pages associated with the insurance currently maintained by POCC, PODC and PMA are attached hereto as Exhibit "A".

WHEREAS effective as of the Functional Consolidation Date, PMA will no longer have employees or hold title to any real or personal property. PMA will remain as a separate legal entity through December 31, 2022 pursuant to the terms of the ILA.

WHEREAS effective as of the Functional Consolidation Date, the CDRPA will own the real and personal property currently owned by PMA, and the CDRPA will manage all real and personal property owned by the POCC and the PODC consistent with the ILA.

WHEREAS the CDRPA shall initially obtain insurance through Enduris, Chubb Insurance, and Colony Insurance Company materially consistent with the coverage set forth on Exhibit "A" effective as of the Functional Consolidation Date. The anticipation is that there will ultimately be three policies, one with Enduris, one with Chubb Insurance with regard to the Airport Owners

and Operators General Liability Policy, and one with Colony Insurance Company. In each case, the CDRPA, POCC, PODC and PMA will be identified as named insureds.

WHEREAS the parties desire to address risk management issues and insurance coverage pursuant to this Resolution. For purposes of this Joint Resolution, "litigation" means (i) any claim by a third party made against the CDRPA, POCC, PODC and/or PMA, whether or not a formal action has been commenced and whether or not the claim is covered by insurance, (ii) any claim, suit or proceeding commenced by the POCC, PODC or PMA against a third party prior to the Functional Consolidation Date, and (iii) any claim asserted by the CDRPA.

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Port of Chelan County, the Board of Commissioners of the Port of Douglas County, and the Board of Directors of the Chelan Douglas Regional Port Authority as follows:

- 1. The CDRPA shall obtain property and liability insurance through Enduris for the CDRPA, POCC, PODC and PMA effective as of the Functional Consolidation Date consistent with the coverage outlined on Exhibit "A". Unless otherwise directed by the CDRPA, in writing, the CDRPA shall be identified as the "loss payee" on all property insurance policies obtained.
- The CDRPA shall obtain Airport Owners and Operators General Liability Policy effective as of the Functional Consolidation Date consistent with the coverage currently provided by Chubb Insurance outlined on Exhibit "A". The CDRPA will also obtain a Storage Tank Pollution Liability Policy through Colony Insurance Company effective as of the Functional Consolidation Date consistent with the coverage currently provided by Colony Insurance Company outlined on Exhibit "A".
- 3. The CDRPA, POCC, PODC and PMA will be identified as named insureds on all policies obtained. The CDRPA shall be the first named insured and will be the only entity receiving notices and authorized to make policy changes.
- 4. The CDRPA is hereby delegated the authority to oversee, direct and manage all pending litigation involving POCC, PODC and PMA and commenced prior to the Functional Consolidation Date, with full authority to settle, compromise and resolve the pending litigation.
- 5. The CDRPA shall manage and oversee the defense of the POCC, PODC, and PMA associated with regard to any litigation commenced after the Functional Consolidation Date associated with a matter arising prior to the Functional Consolidation Date, with full authority to oversee, direct, manage, settle, compromise and resolve the future litigation.
- 6. The CDRPA shall defend and indemnify the POCC, PODC, and PMA, their respective Commissioner, employees, and representatives, in any matter associated with or related to (a) any litigation commenced after the Functional Consolidation Date associated with

any negligence, act or omission, or accusations thereof, of the CDRPA arising after the Functional Consolidation Date, with full authority to oversee, direct, manage, settle, compromise and resolve said litigation, and (b) all acts taken in furtherance of the ILA prior to the Functional Consolidation Date.

- 7. Any litigation commenced by the CDRPA will require future CDRPA Board approval.
- 8. POCC, PODC and PMA release and hold each other and the CDRPA harmless with regard to any actions taken on or after June 11, 2019, related to, associated with, or taken in reliance on this Joint Resolution and the ILA.
- 9. In the event the termination provisions in the ILA are invoked, Sections 3, 4, 5, and 7 shall remain in effect during the pendency of the termination process, unless either the POCC or the PODC provides written notice to the other terminating Sections 3, 4, and 5, in which event Section 10, below, shall apply.
- 10. Nothing herein or in the ILA shall be interpreted as (a) the assumption of any liability, known or unknown, of one party by the other party existing prior to the Functional Consolidation Date, (b) one party becoming the guarantor of the other party, or (c) allocating any liability related to litigation between the POCC or PODC arising after the Functional Consolidation Date.
- 11. In the event of termination of the ILA or if the notice is provided as set forth in Section 7, above, (a) the responsibility for litigation within the scope of Sections 3 and 4, above, shall return to the party against whom, or who commenced, the litigation; and (b) the responsibility for litigation within the scope of Section 5 shall immediately be determined by the POCC and PODC (or a mediator) during the pendency of the termination process, and ultimately allocated as part of the termination of the CDRPA.

This Joint Resolution shall be effective immediately.
