Regional Port Economic Development Initiatives Related to COVID-19 (Third Party Resources) - Kuntz reviewed the COVID-19 grant programs which the CDRPA will administer on behalf of other agencies, including:

- Department of Commerce Working Washington Small Business Emergency Grants (the CDRPA is managing this program as the Chelan/Douglas County ADO)
- Chelan/Douglas County Community Development Block Grant
- Chelan County Grant
- City of Wenatchee Community Development Block Grant
- City of East Wenatchee Community Development Block Grant

Regional Port Economic Development Initiatives Related to COVID-19 (Regional Port Funding) -In addition to the above funds to assist small businesses in Chelan and Douglas Counties, CDRPA staff proposed a "Small Business Support Initiative" in the amount of \$200,000 to further assist businesses in the two-county region. Kuntz reviewed a list of proposed initiatives including:

- Small Business Marketing Fund
- Rent Participation Fund
- Getting Ready to Reopen Fund
- Need Cash Flow Now Fund

Discussions ensued and the Board directed staff to limit the initiatives to just two (Rent Participation Fund and Getting Ready to Reopen Fund). Each initiative will have an overall CDRPA budget cap of \$100,000 and a per business cap of \$1,000. The following action was taken:

COVID-19 - Mid-Term Program Ideas to Support Chelan/Douglas County Small **Business** - Kuntz reviewed some additional ideas to support area small businesses including:

Develop an E Commerce website

- Website development assistance
- A Greater Wenatchee Area "Bucks" program to be redeemed at a discount at local businesses
- Assistance to stimulate business for Alaska Airlines

In addition, Jenny Rojanasthien from GWATA reviewed a proposed program between GWATA and Microsoft to assist small businesses build websites.

CERB Planning Grant - Kuntz and Cridlebaugh provided information on a proposed CERB Planning Grant application concerning the former Giga Watt site. If approved, CERB Grant funds would be used to hire a consultant to determine if the existing buildings on site could be repurposed for other economic development opportunities. Discussion ensued and the following action was taken:

COVID-19 and Pangborn Memorial Airport – Kuntz and Moyers provided information on health precautions at Pangborn Memorial Airport related to COVID-19. Kuntz reviewed what other airports and airlines are doing concerning mask requirements. Discussions ensued and the Board directed staff to strongly recommend passengers wear masks in the terminal building, but not make it a requirement.

CDRPA INFORMATIONAL ITEMS - COVID-19 RELATED:

COVID-19 "Early Opening" Letter of Support – Kuntz reviewed a request to draft a letter of support for the "early opening" of businesses in Chelan/Douglas Counties. Discussion ensued and it was agreed the Regional Port would only draft a support letter if Confluence Health, Chelan-Douglas Health District, and Columbia Valley Community Health were all supportive of an "early opening" plan.

FAA CARES Act Grant – Moyers provided an update on the FAA CARES Act Grant. The airport has not yet received the formal grant offer, but expect to receive it within the next two or three weeks.

Regional Port Tenant Rent Relief Update – Kuntz provided an update on Regional Port tenant's rent relief requests. He will continue to provide updates at future meetings. Discussion ensued.

CDRPA INFORMATIONAL ITEMS:

US Forest Service Helipad – Russ provided an update on the helipad construction project. The project is expected to be complete by May 28th, 2020.

EPA Brownsfield Grant – De Mestre provided an update on the EPA Brownsfield Grant of \$600,000 awarded to the Regional Port. The Regional Port will work with the City of Wenatchee and the City of Rock Island to identify which projects to undertake with the grant funding.

Waterville Library Building – Kuntz provided an update on the potential purchase of the Waterville Library Building.

Airport Terminal Building Parking Lot Review - Kuntz advised the Board the current lease with REEF Parking ends in April 2021. Kuntz suggested staff explore options to determine the best parking lot management strategy moving forward.

First Quarter 2020 Budget vs. Actual – Lough provided a brief update on the First Quarter 2020 Budget vs. Actual. Discussion ensued.

Regional Port Authority Office Space Study Scope of Work – Kuntz reviewed a list of items to be included in a space study for the former Executive Flight Building. Board of Directors provided input on the scope of work.

STAFF REPORTS & UPDATES:

Kuntz provided information and updates including:

- Jack Penning from Volaire Aviation is scheduled to make a presentation at the June 9th, 2020 Regional Port meeting.
- Staffing needs.
- BLM and/or a subcontractor to BLM will lease the old Port of Chelan County building for 3-4 months during fire season this year.

Lough provided information and updates including:

• Update on the phased reopening of the Regional Port offices (safety items such as plexiglass at front desk, masks, gloves, and social distancing).

Moyers provided information and updates including:

- Annual FAA inspection scheduled for June.
- Installing plexiglass in areas of the terminal building is being considered.

OTHER:

Lacey Price, Managing Director of Stage Kids, inquired about leasing 2,000 sq. feet of storage space for costumes and props inside Building F at the Lineage Property. Discussions ensued and staff will proceed with leasing them space.

REVIEW CALENDAR OF EVENTS – The next scheduled Regional Port Meeting is May 26th, the day after Memorial Day. To give staff time to prepare, it was decided to move the meeting to Wednesday May 27th. It will be a "Special" meeting due to date change.

Snow Removal Equipment Bids

Earlier this year, Bids were solicited for a runway broom and a rotary plow. The Bids were opened on March 30, 2020. Paragraph 15.5 of the Instructions to Bidders states, "Owner will give the Successful Bidder(s) a Notice of Award within 60 days after the date of the Bid opening". Additionally, the Invitation to Bid states, "The Owner reserves the right to reject any and all Bids, to waive any and all informalities and to negotiate contract terms with the successful Bidder, and the right to disregard all nonconforming, non-responsive or conditional Bids."

Allotments of FAA CARES Act funds has led staff to reassess the airport's current funding priorities and operational needs. Based on that review and as permitted under the bid documents, staff is recommending that all Bids be rejected. At this time, staff does not anticipate acquisition of runway snow removal equipment this year.

Economic Adjustment Assistance Program

What does the Economic Adjustment Assistance (EAA) program do?

The EAA program provides a wide range of technical, planning, and public works and infrastructure assistance in regions experiencing adverse economic changes that may occur suddenly or over time. These adverse economic impacts may result from a steep decline in manufacturing employment following a plant closure, changing trade patterns, catastrophic natural disaster, a military base closure, or environmental changes and regulations.

Who may benefit from EAA and what will such funding do to promote economic development?

The EAA program can assist state and local entities in responding to a wide range of economic challenges through:

- Strategy Grants to support the development, updating or refinement of a Comprehensive Economic Development Strategy (CEDS).
- **Implementation Grants** to support the execution of activities identified in a CEDS, such as infrastructure improvements, including site acquisition, site preparation, construction, rehabilitation and equipping of facilities. Specific activities may be funded as separate investments or as multiple elements of a single investment.

Why is it advantageous to apply for EAA funding?

The EAA program is EDA's most flexible program. Under the EAA program, EDA can fund market and environmental studies, planning or construction grants, and capitalize or recapitalize revolving loan funds (RLFs) to help provide small businesses with the capital they need to grow.

- The comparative feasibility of the applicant to achieve the outcomes identified in the application;
